On March 27, 2023, both the Intellectual Property Section and the Corporate Counsel Section of the Georgia Bar jointly conducted an in-person CLE seminar titled "The FTC's Proposed Ban on Noncompetes: Everything You Need to Know." This seminar took place at the Georgia Bar Building and was well-attended, with 65 bar members in the audience.

The attendees received an informative and insightful presentation delivered by panelists Serena Moseley-Day, an attorney with the Federal Trade Commission; Benjamin I. Fink, a Shareholder with Berman Fink Van Horn P.C. (BFV); and Samuel C. Burch, General

Counsel and Corporate Secretary, WayForth. Neal Weinrich, also a BFV Shareholder and the Vice Chair of the Trade Secrets Committee, served as the panel moderator.

The FTC extended the comment period for its proposed rule banning noncompete covenants (to be codified at 16 C.F.R. § 910 if implemented) to April 19 after receiving what has been called a "firestorm" of over 16,000 comments. Additionally, the U.S. Chamber of Commerce announced that it intended to mount a legal challenge to the rule if the rule gets approved. The CLE panel predicted that if such approval happens, the FTC's rule would likely take effect 60 days after publication of the final rule in the Federal Register.

Mr. Fink's portion of the presentation discussed the chain of events leading to the FTC's action in proposing its rule, and discussed the provisions of the rule and likely effect of each. Mr. Burch expressed his perspective on how implementation of the FTC's rule would impact mergers and acquisitions, given that employees currently under covenants, and not exempt from the FTC's rule, would then be free to leave the company targeted for acquisition.

The presentation concluded with action items that employers should now be taking to prepare for possible approval of the FTC's rule, including identification and further protection of any trade secrets. If the noncompete ban goes into effect and if the employer identifies potential trade secrets and takes active measures to protect their confidentiality, then the employer would have an option of resorting to trade secret litigation to attempt to protect against disclosure of any trade secret material in the wake of the employee's departure.

Intellectual Property Rights at the Port CLE Delivered at the 2023 State Bar of Georgia Annual Meeting

At the State Bar of Georgia Annual Meeting in Savannah on June 10, 2023, the IP Section delivered a live CLE under the title "Intellectual Property Rights Enforcement: What Businesses that Manage, Transport, Import and Export Goods Need to Know."

Attendees of this CLE presentation learned about the tools and processes for the protection and enforcement of intellectual property rights (IPR) at the port from panelists Morgan McPherson, Attorney-Advisor in the Intellectual Property Enforcement Branch, Regulations & Rulings, Office of Trade, U.S. Customs and Border Protection; Deborah Stern, partner with Sandler, Travis & Rosenberg, P.A.; and Justin C. Ward, Vice President of Legal and General Counsel at Blue Force Gear, Inc. and In-House Committee Co-Chair. Rachel Young Fields, partner with Hunter, Maclean, Exley & Dunn, P.C. and IP Section Communications Chair, served as panel moderator.

The panel discussed the role that U.S. Customs and businesses play in identifying and addressing counterfeit goods. The presentation included insights from U.S. Customs on registration and recordation of intellectual property and how these steps impact enforcement at the border. The panelists also provided an overview of the IPR enforcement process, including detention, seizure, and forfeiture, along with a discussion of available

remedies. The presentation concluded with best practices – for both IP owners and businesses seeking to avoid infringement – to prepare for or prevent IPR enforcement issues at the border.
